# 3. <u>APPROVAL OF THE MINUTES OF FEBRUARY 4, 2011 ALABAMA STATE</u> BAR FOUNDATION BOARD OF TRUSTEES MEETING

### 5. <u>ESTIMATES FOR PLAZA AND RENOVATION WORK TO ALABAMA STATE</u> BAR BUILDING

The Secretary-Treasurer stated that the architects had provided a preliminary costs estimate for the construction work of \$345,126. He stated that the majority of the estimated expense would be for the plaza area in the front of the building. He further explained that the estimated costs would include a complete refurbishment of the two front bathrooms in the original building which had not been changed since the building was built in 1963. He also noted that there would be some enhancements to the receptionist desk as well.

President Spruell asked if there was any further business to come before the Board of Trustees. There being none, a motion was made and seconded to adjourn. The motion was approved.
