4. FINANCIAL REPORT FY 14-15, FIRST QUARTER

5. **BUILDING SECURITY UPDATE**

The secretary-treasurer stated that the first phase of lighting and controlled access to the building had been accomplished and that the committee chaired by Trustee Watson would look at other security enhancements as necessary.

6. <u>APPROVAL OF PURCHASE OF ADMISSIONS SOFTWARE BY THE</u> FOUNDATION AND MONTHLY SUPPORT COSTS

The purchase of the admissions software was previously explained by the Director of Admissions, Justin Aday at the January meeting. The software costs \$60,000 (base price) and \$3,500 per month which includes website hosting, software maintenance and admissions office and applicant support.

TRUSTEE WATSON MOVED TO AUTHORIZED THE EXPENDITURE OF \$60,000 AND \$3,500 PER MONTH FOR MAINTENANCE AND SUPPORT. THE MOTION WAS SECONDED AND APPROVED BY VOICE VOTE.
