3. <u>APPROVAL OF THE MINUTES OF SEPTEMBER 12, 2008 ALABAMA STATE</u> BAR FOUNDATION BOARD OF TRUSTEES MEETING

President White stated that the minutes of the Board of Trustees meeting for September 12, 2008 had been transcribed and submitted to the board in advance of the meeting. He asked if there were any corrections, additions or deletions. There were none.

TRUSTEE GRUENEWALD MOVED TO APPROVE THE SEPTEMBER 12, 2008 MINUTES OF THE ALABAMA STATE BAR FOUNDATION BOARD OF TRUSTEES MEETING. THE MOTION WAS SECONDED AND THE MINUTES WERE APPROVED BY UNANIMOUS VOICE VOTE.

4. FINANCIAL REPORT, FOURTH QUARTER REPORT AND 2007-2008 YEAR END REPORT

The Secretary-Treasurer reviewed the fourth quarter and year-end reports. Following the report, there were no questions.

5. PURCHASE OF SERVERS AND RELATED EQUIPMENT

The Secretary-Treasurer asked the board to approve an expenditure of up to \$33,000 for the purchase of a new file server, web server and storage area network server as well as related software and hardware for installing the new equipment. He stated that the current servers were purchased in 2005 and that the new servers not only had more capacity but had faster processing speed. He noted that the IT staff had recommended Dell equipment at the cost of approximately \$33,000. The competing bid by HP was \$29,000. The Secretary-Treasurer informed the board that when the current equipment was purchased in 2005, the total cost was approximately \$39,000.

TRUSTEE COPELAND MOVED TO AUTHORIZE THE EXPENDITURE OF UP TO \$33,000 for the PURCHASE OF A NEW FILE SERVER, WEB SERVE AND STORAGE AREA NETWORK SERVER INCLUDING RELATED SOFTWARE AND HARDWARE. THE MOTION WAS SECONDED AND APPROVED BY VOICE VOTE.

6. ADJOURNMENT

President White asked if there was any further business to come before the Board of Trustees. There being none, a motion was made and seconded to adjourn. The motion was approved.
