3. <u>APPROVAL OF THE MINUTES OF MAY 6, 2011 ALABAMA STATE BAR</u> <u>FOUNDATION BOARD OF TRUSTEES MEETING</u>

TRUSTEE BROOME MOVED TO APPROVE THE MAY 6, 2011 MINUTES OF THE ALABAMA STATE BAR FOUNDATION BOARD OF TRUSTEES MEETING. THE MOTION WAS SECONDED AND THE MINUTES WERE APPROVED BY UNANIMOUS VOICE VOTE.

4. FINANCIAL REPORT 3RD QUARTER FY2010-2011

The Secretary-Treasurer reviewed the financial report for the third quarter. He asked if there were any questions following his review. There were none.

5. <u>ACCEPTANCE OF BID TO BEGIN WORK ON THE ALABAMA STATE BAR PLAZA</u>

The Secretary-Treasurer informed the commission that five bids had been submitted by contractors for the work to the front of the bar building. He stated that after reviewing all of the bids and discussing the architect with them that it was recommended the bid from Norris Building Company be accepted. He suggested that the commission authorize the expenditure up to \$375,000 to cover the bid price of \$343,000 plus architectural fees.

TRUSTEE WATSON MOVED TO AUTHORIZE THE EXPENDITURE OF UP TO \$375,000 FOR THE PLAZA WORK IN FRONT OF THE BAR BUILDING. THE MOTION WAS SECONDED AND APPROVED BY VOICE VOTE.

6. ELECTION OF OFFICERS FOR THE 2011-2012 FOUNDATION YEAR

President Spruell stated that James R. Pratt, III and Keith B. Norman were nominated as foundation president and secretary-treasurer respectively.

TRUSTEE WHITE MOVED TO ELECT JAMES R. PRATT, III AS PRESIDENT AND KEITH B. NORMAN AS SECRETARY-TREASURER OF THE ALABAMA STATE BAR FOUNDATION. THE MOTION WAS SECONDED AND APPROVED BY VOICE VOTE.

President Pratt asked if there was any further business to come before the Board of Trustees. There being none, a motion was made and seconded to adjourn. The motion was approved.
