## APPROVAL OF AGENDA

MOTION TO APPROVE AGENDA FOR JULY 18, 2024, BY BRANNON BUCK, SECONDED BY FRED HELMSING, AND APPROVED BY UNANIMOUS ROLL CALL VOTE.

## PRESIDENT'S REPORT

President Perry reported on the successful annual meeting. Since becoming President, he and Executive Director Lovell were invited to lunch with Chief Justice Parker. Perry indicated the Chief Justice offered his continued assistance to the bar and spoke of the improved relations with the Court. Perry complimented Brannon Buck, Terri Lovell, and the staff for their vigilance in maintaining these relationships. Perry also stated he was honored to present Lynn Jinks with his 50-year member pin in a ceremony held in Union Springs, Alabama last week.

## **EXECUTIVE DIRECTOR'S REPORT**

Regarding the operations side of the bar, Executive Director Terri Lovell informed the committee preparations are being made for the executive committee retreat. She intends to offer proposed plans regarding staff compensation and leadership development at the retreat. Building maintenance issues are ongoing regarding the HVAC and three bids have been obtained. Lovell announced the pending retirement of Linda Lund, Director of the Volunteer Lawyers Program.

On the regulatory side, Lovell stated this would be the largest bar exam since Covid with over 600 testing of which 127 are seeking special accommodations. The Supreme Court has given preliminary approval for the bar exam to be moved to Birmingham beginning in February of 2025. This location will be in closer proximity to approximately 70% of those sitting for the exam. Lovell further stated she anticipates a substantive report to be provided to the Supreme Court regarding the pending changes by NCBE to the bar exam. Rule changes regarding the application process, approved by the BBC at the annual meeting, have been forwarded to the Supreme Court for their approval.

As it relates to programs, Lovell stated interest has increased regarding participation in section and committee involvement. Committees are in the process of being finalized of which it will be necessary for over 1,000 appointments to be entered into the database system. Fifty-year milestone celebration preparations are ongoing for the event to be held September 19, 2024, at Ross Bridge in Birmingham. The 2023-2024 Annual Report was mailed to all past presidents and bar staff are in the process of finalizing annual reports for committees and task forces.

## **GENERAL COUNSELS REPORT**

General Counsel Roman Shaul provided an update on the Rule 7 series changes (Rule 7.1-7.6). Michael Upchurch has provided a memo to the Court and an additional clarification memo will be

provided to the Court to address expressed concerns. He discussed the ongoing OGC database implementation and the new features it would provide.

## **ALF APPOINTMENTS**

Past President Brannon Buck informed the committee that due to an oversight at the annual meeting, two individuals, recommended by the Alabama Law Foundation, were not voted on by the Board of Bar Commissioners. Due to exigent circumstances, Buck felt the Executive Committee could vote for the approval of these individuals and seek ratification of this decision at the next BBC meeting. During discussion, Ron Strawbridge recused from any discussion or participation in the matter.

A MOTION TO APPROVE THE APPOINTMENTS OF AUDREY STRAWBRIDGE AND JEFF McLAUGHLIN TO THE ALF BOARD WAS MADE BY BRANNON BUCK, SECONDED BY FRED HELMSING, AND APPROVED BY UNANIMOUS ROLL CALL VOTE.
